Borates. No borates are used in the manufacture of the product.

Wood preservatives. No wood preservatives are used.

**Wood.** We confirm conformity with the PEFC standard PEFC ST 2002:2020 with our certificate number HW-CoC-0296-19. The proportion of PEFC-certified wood in the designated product is 90 %. The wood used to manufacture the product comes exclusively from regional, sustainably managed forests in Germany. No recycled wood is used in the manufacture of the product.
